Board Directors' Duties Sue Harris presented a paper to the Board reviewing the six duties of directors set out in the *Corporations Act 2001*. Those duties are:

1. To act in good faith and for a proper purpose,
2. To act with reasonable care and diligence,
3. To prevent insolvent trading,
4. To prevent an improper use of position,
5. To avoid misuse of information, and
6. To prevent conflicts of interest
